Subject:- Category Change from Independent to Govt. And Extension of Affiliation

Sir/Madam,

This is with reference to your application No. EX-00726-1718 regarding the extension of Affiliation beyond session 31:03:2016.

In this connection, it is to informed you that "Due to Affiliation committee Meeting held on 24.05.2012 and it was resolved that all such schools which are being run by the different Ministry/Department/Govt organisation/Undertakings directly or indirectly by creating their own societies may henceforth be put under Govt/Govt. aided/School category. The above said decision of the affiliation committee had further ratified by the Governing Body of the Board in its meeting held on 04.06.2012. Due to amendment in Affiliation Bye-laws, rule 3.2(IV) affiliation once granted to the schools run by the Govt./KVS/NVS/CTSA will be considered as Regular Affiliation. The school falls under the govt. category need not apply for extension of Affiliation again. However, it is mandatory for these schools to remit Annual fee @ 3000/- per annum. Therefore, the School is required to clarify the following points before change the category from Independent to Govt. school.

- 1. The School is required to submit the certified true copy of establishment letter issued by the Competent Authority of the school i.e. concerned Department of State/U.T./Central Govt. showing that the school is run by concerned Department of State/U.T./Central Govt. and it comes under the Govt./Govt. Aided Category.
- 2. The School is required to submit the certified true copy of current Grant-in-Aid sanction letter issued by the concerned State/U.T./Central Govt. may please be furnished showing that the salary of the school's staff is being paid by the State/U.T. Central Govt.

The School is required to submit salary statement showing that the salary DA and other allowances is being paid either at par with the State/Central Govt. teachers or as per provisions of VIIth pay commission of Central Government. A documentary proof of it to be submitted in this office. Also a copy of acquaintance roll for the last 03 months along-with Banker Certificate is required to be submitted.
- 4. The School is required to submit the Fee structure of each class.

5. The school is required to submit safe drinking water, sanitary condition and fire safety certificate duly signed and stamped of the Competent/Concerned Authorities of the State, as per appendix VII and VIII(Copy Enclosed) of the Affiliation Bye-laws of the Board.


Further necessary action in the matter will be initiated after the receipt of compliance of above points.

Sub: Decision to change the category of schools run by the society created by the different Ministry/Department/Govt.Body/Undertaking-reg.

Sir.

You are aware that as per rule 3.1 under chapter-II of Affiliation Bye-Laws, the Board affiliates several categories of school all Over India and Abroad, as for example:-

Government of Government aided schools;

- Schools run by autonomous Organisations under the Government like Kendriya (ii) Vidyalaya Sangathan (KVS), Navodaya Vidyalaya Samiti (NVS), Central Tibetan Schools Organisation (CTSO), Sainik Schools Society etc.
- (iii) Schools run by Government Department directly like Defiance, Railways etc. (iv)
- Schools managed directly by Public Sector Undertakings or by reputed societies for Public Sector Undertakings under the financial control of such Public Sector Undertakings or by Societies formed by such undertakings. (v)
- Private, unaided schools established by societies registered under the societies Registration act, 1860 of the Government of India or under Acts of the State Governments as educational, charitable or religious societies having nonproprietary character with certain condition.

As of now, Sainik Schools, Rashriya School, Army Schools/Army Public Schools. Naval Schools/Naval Public Schools, Air Force Schools and Schools run by different Ministries/Departments directly or indirectly by creating their own societies have been put under the Independent category of school considering that these schools are run by Ministries/Department/Undertakings Central/State/U.T Govt. resulting to non admissibility of certain relaxation/benefits which other are available to Govt./Govt.aided schools.

Of late, the Board has consider this issue in its affiliation committee Meeting held on 24.05.2012 and it was resolved that all such schools which are being run by the different Ministry/Department/Govt. Organisation/Undertaking directly or indirectly by creating their own societies may henceforth be put under Govt./Govt. aided/school calegory. The above said decision of the affiliation committee had further been ratified by the Governing Body of the Board in its meeting held on 04.06.2012.

Therefore, in the light of the above decision, I am directed to inform you that Government Model School, Shahpurkandi Township (RSD Project) Tehsil & Distric Pathankot, Punjab-145029 school managed by Ranjit Sagar Dam Project (Shahpurkand Township) Department of Irrigation, Government of Punjab (India) affiliated vide Affiliation No. 1630085 now stands affiliated under Govt./Govt. aided category with
